

## HIO Terms and Conditions

**Payment:** A valid check for the tournament fee payable to Golf Event Planning must be postmarked prior to the tournament.

**Confirmation of Terms:** All subsequent changes to the terms discussed must be approved by Golf Event Planning in writing. No change in the hole #(s), yardage(s), prize value(s), or tournament date(s) is allowed unless approved in writing by Golf Event Planning. Tournament fees are based on two categories of shots: those taken by Amateurs, and those taken by Professionals. In order to have a valid Agreement, the number of shots to be taken by each category of player must accurately be stated. If any past or present professional golfer is eligible to win any hole-in-one prize, that individual must be counted as a Professional participant in the Agreement. The names and likenesses of the Client, Acing Golfer (Winner), and Hole Sponsor, if any, may be used by Golf Event Planning without further compensation to the Client, Winner or Sponsor.

**Witnesses:** Prizes up to \$2,000 – Three (3) playing partners of the Winner; Prizes from \$2,001 to \$59,999: Club Professional, Representative, or Tournament Official, who is an independent person over the age of 18 and not having a conflict of interest, shall be stationed at the selected hole at all times during the Tournament; Prizes of \$60,000 and greater require two (2) such witnesses; Prizes of \$100,000 or greater require a raw, unedited video tape of the entire event in addition to the required witnesses and also a PGA Club Professional.

**Yardage:** The Target Hole(s) will measure from Tee to Flagstick, no less than the specified yardage of the Agreement. Women may shoot at the Target Hole(s) at a distance of up to fifteen (15) yards less than the men. In no event may the yardage be less than 160 yards men/145 yards women.

**Shots:** A shot is a stroke as defined by the USGA Rules of Golf. No practice shots or mulligans are permitted on the Target Hole(s). Each category of authorized number of shots is permitted only during the stipulated round(s) of the Tournament on the Date(s) specified in the Agreement.

**Prize Restoration:** Unless otherwise specified, the Prize Value is automatically restored to its original Value for each and every hole in one. The Prize Value does not restore for Prize Values of \$250,000 and greater.

**Eligibility:** The hole in one must occur by an officially registered player in the specific Tournament listed in the Agreement.

**Claim Notification:** Immediate telephone notice by Client to Golf Event Planning is required no later than the first business day after the Tournament.

**Proof of Claim:** Client will furnish to Golf Event Planning the following:

Certification of the hole in one by the Winner, Witness(es), Club Pro or Club Secretary, and Tournament Official.

Original and Official Scorecard of the Winner for the Tournament Date on which the Hole in One was made, attested by at least two (2) playing partners.

Proof of Claim Form; and a W-9 Form, completed by the Winner.
